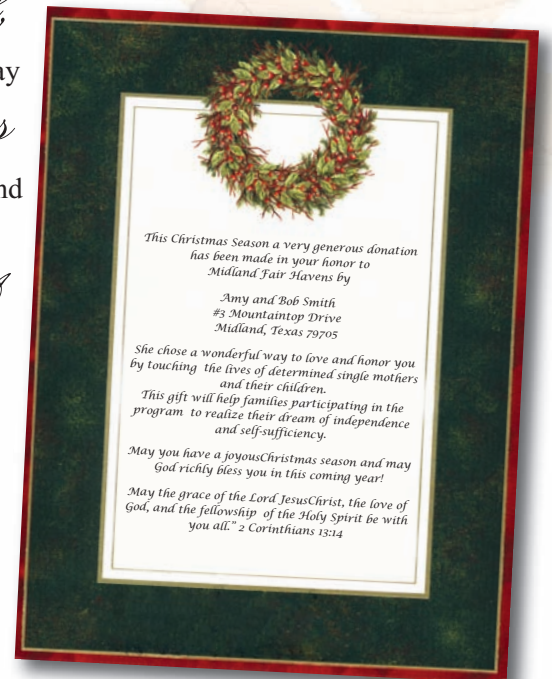

provided much needed school supplies and clothing for our families. We are so very thankful for each of these treasured supporters!



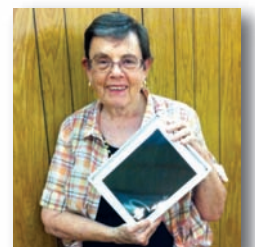
